The aim with the conference is to bring researchers together from different countries and to discuss the latest trends and issues related to accounting. CONFERENCE TOPICS

The special topic of the conference is "Contemporay issues of information technology in accounting". PhD COLLOQUIUM and WORKSHOP

We strongly encourage PhD-students and their supervisors to submit work in progress for presentation and to receive quality feedback from an appointed international reviewer and to contribute from advice from the audience. The participants of the PhD-colloquium will also have the opportunity to attend a short workshop and also discuss their research problems with international participants.

PUBLICATION

All submitted papers will be reviewed by an international scientific committee (two blind reviews).

- Authors of all accepted papers must submit a ONE-PAGE ABSTRACT that will be published in the digital conference proceedings with ISBN number.
- Authors have the option of sharing the full paper at the conference webpage.
- The two best papers after the conference will be selected for publishing (after normal review process) in Engineering Economics (indexed in Thomson Reuter's Web of Science) and Theoretical Journal of Accounting. Other accepted papers will be eligible for consideration for publication in the Theoretical Journal of Accounting and Engineering Economics where they will be subject to the normal review process.
